Liability Statement

ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION: This document waives very important legal rights. **READ IT CAREFULLY BEFORE SIGNING.**

In consideration of JMJ EnterpriZes permitting me to participate in this competition, and by signing the entry form, I agree as follows:

- ❖ I agree that I choose to participate voluntarily in this competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor or as the parent or guardian of a junior exhibitor. **I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING BUT NOT LIMITED TO RISK OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN AND SUFFERING AND PRIPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.**
- ❖ I agree for myself my heirs executors, administrators, successors and assigns to release JMJ EnterpriZes, the competition, the facilities (leased by the competition) and owner(s) of the facilities and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and all claims for damages, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent permitted by law and arises out of or relates in any way to the competition and my participation in the competition **INCLUDING BUT NOT LIMITED TO DAMAGES, LOSS OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER ENTRANTS. THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES**, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defect in the premises.
- ❖ I agree to indemnify and hold harmless (that is pay all losses, damages, attorneys' fees and costs of) the Released Parties from and against any and all claims, demands, penalties, actions, losses, costs, damages, injuries liabilities and obligation (including attorney's fees) of whatsoever kind and nature, which may be asserted against or incurred by any of them as a result of (1) my participation in the competition or (2) any act, failure to act or neglect (a) by me, (b) by any animal owned or exhibited by me or in my custody or control.
- ❖ I agree and represent that I am qualified and eligible to enter and/or participate in the competition and every horse I am entering is qualified and eligible as entered.
- ❖ I agree to **ACCEPT AS FINAL** any decision of show officials concerning my qualification or the qualification of my horse to enter the competition or any results of the competition

THIS JMJ ENTERPRIZES ASSUMPTION OF RISK, RELEASE AND INDEMNIFIATION IS GOVERNED BY THE LAWS OF THE STATE OF TEXAS AND IS INTENDED TO BE INTERPRETED AS BROADLY AS POSSIBLE. I AGREE THAT EXCLUSIVE JURISDICTION AND VENUE (PLACE) FOR ANY LEGAL ACTION AGAINST JMJ ENTERPRIZED, ITS OFFICERS, DIRECTORS, EMPLOYEES, VOLUNTEERS OR AGENTS SHALL BE IN THE LOCAL DISTRICT COURTS OR THE FEDERAL COURT OF THE STATE OF TEXAS.
